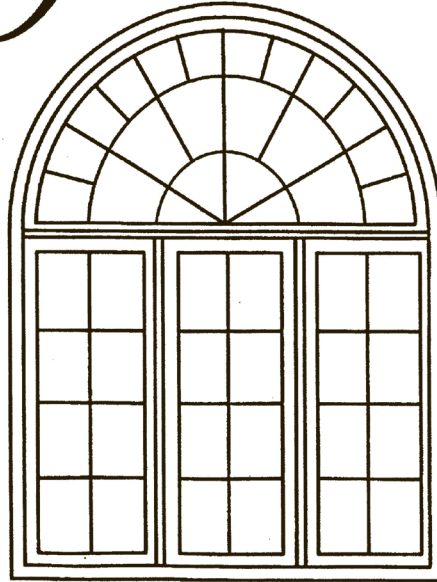
News About Your Neighbors

JOIN THE CRIME ALERT! Want to know what’s going on around you? Join the GRDC Crime Alert system and you’ll get email messages to update you.

The GRDC Community Security Program’s staff monitors and sends out email crime alerts as reported by community residents about recent suspicious or criminal incidents or activities. Our goal is to provide timely information to residents and when possible and appropriate, to offer crime prevention strategies and reminders that may help keep us safer in the future.

To join the Grandmont Rosedale Crime Alert system, send an e-mail request to grandmontrosedalecrimealert@googlegroups.com. And please share this invitation and e-mail address with other neighbors and friends who also live in the Grandmont Rosedale area.

NOTE: This alert system is designed to help increase our awareness for our own personal safety and/or to show possible trends and to help increase the arrest and prosecution rate of criminals. This alert system is not to be used for community announcements about programs or activities, but only for reporting

suspicious or criminal activity or crime prevention tips. We also ask that people not “reply” to any given incident via the system, but instead to direct comments to info@grandmontrosedale.com or call and leave a message at 313-387-4732, ext. 100.

VACANT HOUSE and SQUATTER ALERT – Do you have any vacant houses on your block? Do you suspect squatters may be occupying a vacant house on your block? If so, please give GRDC Vacant Property Intern Braden Latham-Jones a call at 313-387-4732, ext. 117, and report the addresses and as much other information posted or available to him (or send an email to blathamjones@grandmontrosedale.com).

NOTE: In Rosedale Park, contact Stacy Pugh (313-574-8889) to report suspected squatters and contact Debbie Kent (313-836-4737) to report vacant property. If the house or suspected squatters are in North Rosedale Park, contact Clarendia Webb (313-330-7844). If the house or suspected squatters are in Grandmont, contact Diane Patterson (313-836-3736).

It takes a LOT of people to keep track of and take care of all of the vacant houses in our neighborhood. Please do all that you can to maintain the yards of the vacant houses on your block – pick up trash and flyers, and do what you can to make the house look occupied. If you are already taking care of vacant houses in your community, THANK YOU and thanks for being a good neighbor!

How About a New Tree in Front of Your Home?

One of the most distinctive and attractive features of our beautiful Rosedale Park neighborhood is the presence of the wonderful trees that line our streets. Lately, however, many of these mature trees have come down, due to storms and their age.

We now have an opportunity to replace some of those missing trees. The Greening of Detroit will donate trees to our neighborhood through their community tree-planting program. To qualify for this program, Rosedale Park Improvement Association must locate at least 10 neighbors who will request trees and also agree to the Greening's requirements, including supplying at least two volunteers per tree to dig the holes and plant the trees, and agreeing to water and maintain the new trees for the first three years.

The planting of these trees will occur in March 2013, in the public spaces in front of homes, an area called the "berm." If you would like a free tree to be planted in front of your home, please send an email to Pam Weinstein at weinstein148@ameritech.net, so that we can add your address to the list. Deadline for submitting your name and address is Dec. 15, 2012.

Once the list is established, The Greening of Detroit will group the locations, concentrating on adjacent streets to ensure technical assistance is readily available to all volunteers on the planting day(s). You will be contacted to let you know when your location is scheduled to receive a tree.

The Greening and RPIA will supply additional volunteers, tools, and instructions, but your household is responsible for producing at least two volunteers to participate on the day

your tree is planted. Those volunteers could be you, a family member, a friend, or a neighbor.

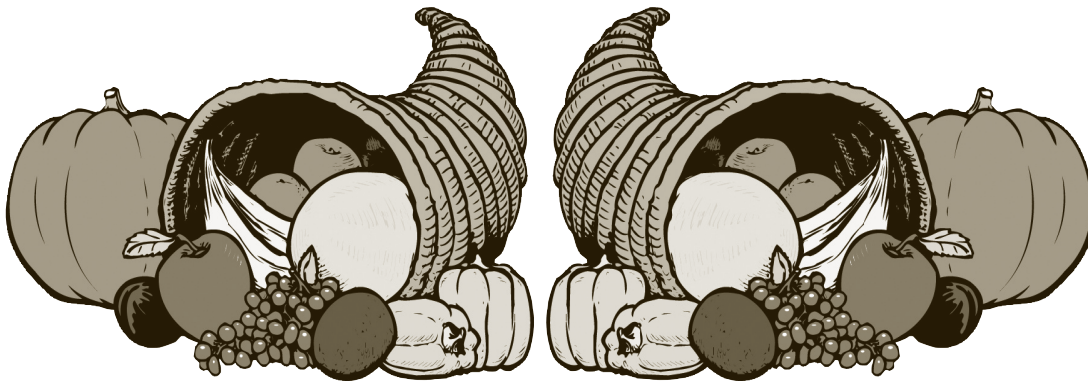
RPIA Board Meeting Minutes

RPIA General Membership Meeting Minutes

September 11, 2012

The meeting was called to order at 7:01pm by RPIA Board President Mary McLeod.

Mary began the meeting by acknowledging current RPIA board members and block captains in attendance.

Vista Maria Foster Care Awareness

Vicki Taylor from Vista Maria explained the volunteer opportunities available at Vista Maria. Vista Maria is an organization that serves the needs of at-risk children right in our community. This is done through various in-patient and outpatient treatment programs and foster care. Ms. Taylor was accompanied by a foster parent who shared her rewarding experience in fostering children through Vista Maria. The need for foster parenting is great and even greater within the teenage group. There is a lot of support in caring for teenage children. There is no age limit to fostering; and your status could be married or single. If fostering is not an option, there is also a need for mentors and volunteers at Vista Maria. Ms. Taylor was on hand for questions and provided supportive information to those interested.

DTE: Conserving Energy and Saving Money

DTE's purpose in attending the meeting was to continue the partnership they have established within our community. DTE provided those in attendance with energy saving pamphlets, trinkets and information on setting up free home energy audits. DTE provides an e-newsletter and encouraged members to sign up to receive it.

Jason Kupser from the Marketing Dept. at DTE gave a presentation on why energy efficiency is important to the consumer, to DTE, and the community. The main reason is to save money both personally and for the local economy. These savings are poured back into local communities and help in creating new jobs. Mr. Kupser provided tips for consumers in picking appropriate products for energy efficiency and the environment. Additional reasons to save energy would be for safety and comfort. Mr. Kupser detailed how heat travels throughout a house. He detailed the three major ways to tackle insulation issues in order of priority: seal air leaks, insulate, and upgrade windows. DTE offers a free home energy consultation program to residents to assist with energy efficiency. After DTE performs an energy audit on a home, they offer rebates for wall, ceiling, crawl space insulation, windows, and air sealing work done as a result of a need found during the audit.

Environmental Agenda and Survey

Margaret Weber provided an environmental survey and encouraged residents to fill it out and return it at the meeting. City officials are seeking input from residents on the impact of the environment on our quality of life.

Currently, residents that live north of Fenkell are participating in the pilot curbside recycling program. Margaret provided brochures and refrigerator magnets that detailed the current changes to the program that included the collection of glass (brown, green, and clear), septic containers (milk and juice containers), and clean pizza boxes that are not loaded with grease. Plastic bags will no longer be collected; bags can still be brought to Christ the King every third Saturday during Rosedale Recycles days. Rosedale Recycles is still pushing to get the curbside recycling effort to the residents south of Fenkell, so stay tuned.

Neighborhood Benefits District

Stacy Pugh provided an explanation and update on the special assessment district initiative. This is a coalition of representatives from the five communities in the Grandmont Rosedale area (Rosedale, North Rosedale, Grandmont, Grandmont 1 and Mincock Park) working to help the city in determining the services that are actually needed in our community. The main purpose of the neighborhood benefits district (NBD) is in being proactive in crime prevention and improving the quality of life for city residents.

The NBD committee is spear heading an effort to have a small fee assessed to property owners specifically to pay for services like snow removal, security and mosquito abatement. The main advantage is to provide a consistent and sustainable funding source for key services to improve the quality of life for residents. This is not an effort to replace what is already in place to aid residents, but to expand and improve upon what services we have and give residents access to services that are not available but found to be a need.

The coalition is in the process of working with lawyers who have volunteered their time to put together an ordinance to present to the city council for approval. Financial budgeting to carry out the needed services will accompany this and then residential voting on the ordinance will commence. This process could take up to 18 months for completion.

GRDC Community Updates

Tom Goddeeris provided a brief update on the building sustainable communities program, current GRDC programs, and the Detroit Works project.

The building sustainable communities program has developed a quality of life plan addressing neighborhood stabilization, community security, commercial revitalization, beautification and place making, youth development, and community engagement.

GRDC programs mirror the efforts outlined in the building sustainable communities program. They are working in conjunction with the neighborhood benefits district committee and the Northwest Detroit Farmer's Market. They are also beginning work on an online business directory, and developing a web portal that combines all of the information on all neighborhoods within the Grandmont Rosedale area. The main effort of GRDC is in vacant house rehab and Tom provided a statistical update on the houses that have been rehabbed, sold and the funding efforts to accommodate this project.

The Detroit Works Project looks at strategies for improving Detroit for the long haul. These strategies include housing, employment, proper use of environmental systems, and city services. They are in the final stages of information gathering from the community meetings before releasing a final document detailing the meetings.

Announcements – Wrap Up

Mary read the slate of officers that will be running for board election at the next general membership meeting on November 13th. A complete list will be published in the RPIA News for review. All residents were encouraged to come out to take part in the elections.

The meeting was adjourned at 8:52pm.

With a little help from her friends

Rosedale Resident Fights Eviction, Saves Her Home

It wasn't at all what you'd expect of another court-ordered foreclosure and eviction. No frantic scurrying to salvage belongings, no carpenter waiting to board up the windows with plywood, no fearful children watching in numb bewilderment, no court bailiff directing the removal of furniture to a curbside dumpster. In fact, there was no dumpster in front of the corner house on Warwick and Midland.

Instead, there was a crowd of neighbors, friends, and supporters, gathered on the lawn and street. Some were drinking coffee as the sun rose in the summer sky, some were sitting or standing in small groups talking—and laughing. And some were standing at nearby Grand River Avenue with signs asking drivers to “HONK IF YOU OPPOSE FORECLOSURES.” A ragged chorus of car horns filled the air.

There would be no eviction because these people had announced that many among them were prepared to peacefully prevent the placing of a dumpster in front of the home of longtime Rosedale Park resident Jennifer Britt. So long as they occupied the street, the dreaded dumpster could not be deployed and another unjust eviction would be stopped before it started.

Their vigil lasted over a month, dawn-to-dusk every weekday, interspersed with rallies, barbecues, driveway meetings, and the occasional visit from Fox News and the *Metro Times*.

This remarkable turn of events would have been hard for Britt to imagine six years ago, when her husband Leon died and the mortgage first went into default. She used his life insurance settlement to make the loan current, but two years later she was laid off, right at the start of the Great Recession.

Britt kept paying the mortgage out of savings and asked Flagstar Bank for help with a loan modification. Instead, the bank *raised* her monthly payment after 2006, eventually taking \$46,000 from Britt and forcing her into foreclosure. She depleted her life savings on the hope that Flagstar would reconsider a modification, but the bank had no interest in modifying the loan.

Unknown to Britt, Flagstar had already sold her mortgage at full value to Fannie Mae, the now-insolvent mortgage banker taken over by the federal government in 2008. Flagstar was just a servicer, collecting a handsome fee for sending Britt's payments along to Fannie, which owns or guarantees nearly half of all single-family mortgages in the United States.

As a matter of policy, Fannie Mae sells foreclosed homes to investors at less than market value, but won't write down mortgage principal to keep people in their homes. Even after Britt found new employment and offered to buy her house back at market value, Fannie Mae refused and got an eviction order.

Unlike the many homeowners who feel shamed by their circumstances and alone in their peril, Jennifer Britt was determined to save her home and find friends who would help her. She started by going to a free legal clinic organized by the Eviction Defense Committee of Occupy Detroit. There she found activists and homeowners fighting unjust evictions with a combination of courtroom strategies and peaceful direct action. Neighborhood canvassing and rallies at Britt's home built a network of supporters, while informational picketing of Flagstar Bank and the Federal Building drew allies from the 99%.

The day of the scheduled eviction, more than 100 supporters kicked off the month-long vigil, protecting Britt's home in rotating shifts. Spurred by this public protest, the offices of Senators Stabenow and Levin began pressuring Fannie Mae to do the right thing.

And that's what finally happened. The details are confidential, but the bottom line is that Britt may soon be able to purchase her home under a 30-year mortgage from the Opportunity Resource Fund, a non-profit housing agency.
